## 3 Contribution Rules of the European Ukrainian Bridge e.V.

The European Ukrainian Bridge | Europäisch Ukrainische Brücke (EUB) e.V. charges its member companies and individual members (private persons) a membership fee per business year.

The amount of the membership fee for companies is determined by the number of employees of the member company. The membership fee shall be paid in full on 1 January of the current business year.

The Executive Committee may exclude members from the Association who have not paid their dues by 31 December of the respective financial year.

Members may apply through the management of the Association for a deferment of the payment of dues until the end of the current financial year.



The year of operation shall be the calendar year.

Resignation from the Association is only possible at the end of a calendar year. The notice of resignation must be received by the Executive Board of the Association in text form no later than six months before the end of a calendar year.
